This study will investigate reward system dysfunction by combining longitudinal assessments of neural measures of cue reactivity with ecological momentary assessment of drug cue exposure in the real world, craving, and use in daily life. We will recruit individuals into four groups: those who use cannabis and alcohol simultaneously, those who use alcohol only, those who use cannabis only, and controls who report minimal alcohol and cannabis use. The proposal will focus on neural changes in reward networks that occur over time (3 multimodal assessments over 2 years) that are moderated by group status, the relationship between drug cues and craving or use in the real world, and the moderating role of neural responses to cues on the associations between cues and craving/use in the real world.

"Short-Term Suicide Risk Processes for Sexual Minorities at the Intersection of Sexual Orientation, Gender, Race, Ethnicity, and Geographic Location"

Heightened suicide thoughts and behaviors (STBs) prevalence for Sexual Minority (SM) with multiple marginalized sexual orientation, gender, and racial and ethnic identities could be due to these individuals experiencing compounding forms of discrimination. Further, STB prevalence could be even higher when individuals with multiple marginalized identities live in rural areas, because rural areas are high-stigma, low-resource contexts. This R01 will address critical research gaps by applying an intersectional lens to determine how multiple forms of discrimination and discrimination contexts impact short-term STB risk processes among SM adults. The aims will address (1) how daily discrimination experiences increase short-term STB risk, (2) how these effects vary by intersectional identities, and (3) whether geographic context moderates how daily discrimination increases STB risk among SM.
